

# Message from your Chief of Police

The physical combination has taken place very efficiently, with the formal union occurring the beginning of 2023. However, our physical loss has provided an improved working experience for our dispatchers, with better staffing to handle the challenges of controlling emergency and non-emergency responses of both the police and fire departments. 
OPD operational discussions have revolved around three specific questions: What are we doing right? What are we doing wrong? What can we do better? Asking and answering these questions has helped us to better allocate our resources, and improve our efforts to provide police services in a more efficient manner. These questions have not stayed inside the Department. As a department, we have solicited feedback from everyone we interact with in an official capacity. ### **Patrol Division**



Captain BJ Robinson commands the Patrol Division of the Police Department, which includes Patrol, Traffic Unit, K9 Unit, and several specialty assignments within the Division. Captain Robinson's career in law enforcement began in 1998 as a patrol officer with the Pleasant Grove Police Department. He later made a lateral move to the Orem Department of Public Safety – Police Division in 2001. Captain Robinson has worked in a variety of assignments throughout the Orem Police Department to include Special Victims Unit, Utah County Major Crimes Task Force, and SWAT Team Operator. Captain Robinson has had assignments as supervisor or commander within the Investigations Division, Patrol Division, and served as the Director of the Utah County Major Crimes Task Force.

The mission of the Patrol Division is to ensure the security and safety of all who work, live, study, or visit the City of Orem. Accomplished through professional and timely public safety services, our officers proactively patrol assigned areas 24 hours a day, 7 days a week, 365 days a year. The Division consists of 62 uniformed police officers including 1 Captain, 3 Lieutenants, 7 Sergeants, and 51 Police Officers. Working to enhance our level of service to the citizens, assignments within include the Traffic Unit and K9 Team.



Lieutenant Scott Rich is a Patrol Division Commander charged with supervision Tuesday through Friday. This includes the operations of patrol sergeants, police officers, animal control, and the civilian personnel who work to supply our citizens with 24hr public safety and crime prevention measures. Lt. Riches' duties include ensuring the proper staffing levels for deployment of officers across three Patrol shifts. The patrol shifts consist a Sergeant, a Corporal, and five to six Officers. Members of our Police Department strive to build closer bonds with the community, and are encouraged to meet and talk with people in non-enforcement roles on a daily basis. Lt. Rich is also the direct supervisor for our Traffic Unit, and a certified Motor Officer.



Lieutenant Jeremy Jamison is a Patrol Division Commander charged with supervision Thursday through Sunday. This includes the operations of patrol sergeants, police officers, animal control, and the civilian personnel who work to supply our citizens with 24hr public safety and crime prevention measures. Lt. Jamisons' duties include ensuring proper staffing levels for deployment of officers across three patrol shifts. The patrol shifts consist a Sergeant, a Corporal, and five to six Officers. Connecting with the community is a priority within the Police Department, and our officers strive to gain understanding of the daily challenges our citizens endure. Lt. Jamison oversees the K9 Team, as well as coordinating the Crisis Intervention Team (C.I.T.) training for the Department and many surrounding agencies.



Lieutenant Phil Anderson is a Patrol Division Commander charged with supervision Monday through Thursday. This includes the operations of patrol sergeants, police officers, animal control, and the civilian personnel who work to supply our citizens with 24hr public safety and crime prevention measures. Lt. Andersons' duties include ensuring proper staffing levels for deployment of officers across three patrol shifts. The patrol shifts consist a Sergeant, a Corporal, and five to six Officers. Lt. Anderson also oversees the operations of our department Firearms Range and is a Firearms Instructor.


No day is routine for America's Law Enforcement Officers. The average day of a Orem Police Officer is spent answering calls-for-service, traffic enforcement to include issuing traffic citations or warnings, investigating traffic collisions, making arrests, writing reports, making face-to-face non-enforcement contact with the community, and many other actions and activities throughout the day. The Police Departments' officers spend countless hours conducting proactive patrols throughout the city in business districts, high density housing areas, and our local neighborhoods in the effort to reduce crime and increase our visible presence.

#### **Traffic Unit / Motors**

The Police Department's Traffic Unit is comprised of one Sergeant and three Officers. One of the officers' primary operational duties is to target impaired drivers and alcohol enforcement. Our OPD team's mission is to provide a safer city through traffic enforcement, education, and innovation. This is sought through efficient and focused traffic law enforcement in high volume vehicle and pedestrian commute locations. The traffic team can be seen throughout the city in their primary patrol vehicles, as well as police motorcycles with weather permitting.





### Patrol Division

#### K9 Team

Our K9 Team consists of three handlers deploying two dual purpose dogs and one K9 currently in the training for deployment. The dogs are Belgian Malinois, maintained and owned at department expense. Both handler and K9 certify annually and train continuously to maintain a high level of proficiency and professionalism. The department K9 Team has proven successful in detecting the presence of drugs during traffic stops, search warrants, and aiding in the apprehension of dangerous criminals hiding from police.

During the 2021/2022 year the K9 team responded to 231 requests for canine assistance.



#### **Metro SWAT**

The Orem Police Department partners with local agencies to combine resources and manpower with the goal of providing our communities with professional tactical emergency services of the highest quality. Provo, Orem, BYU, and UVU police departments are all member agencies of this team. Members train regularly, initially completing a SWAT school deemed "HELL WEEK", similar in nature to military basic training. Members continue on afterward and become specialists in areas such as sniper, scouts, explosive entry and breachers, and operators.

The 2021/2022 year saw Metro SWAT Team was called out to 2 high risk incidents. These incidents were related barricaded subjects, high risk warrants services, and various other details which require the capabilities of a highly trained tactical unit.

# **Investigations Division**



Captain Todd Mallinson commands the Investigations Division of the Police Department, which includes units and specialties such as the Utah County Major Crimes Task Force, Special Victims Unit, General Investigations, and Mental Health Unit. A veteran law enforcement officer, Capt. Mallinson began his career in 1988 with the Pleasant Grove Police Department, later transferring to the Orem Department of Public Safety – Police Division (as it was known then) in 1993. The Captain has commanded all three of the Departments' divisions within his career, as well as serving in all areas as Lieutenant and Sergeant, Watch Commander, and the Director of the Utah County Major Crimes Task Force.

The Investigations Division of the Orem Police Department consists of 26 full-time detectives and four civilian employee's, divided into the following specialties and units: Fraud and Computer crimes, Gangs, Neighborhood Improvement Team, Property Crimes, School Resource Officers, Sex Crimes, Child Abuse, Crimes Against Persons other than sex crimes), Mental Health Unit, Crime Analyst, and the Utah County Major Crimes Unit. We also have three Victim Advocates assigned to the Division to assist with the unique needs of crime victims. Detectives are subject to "call-out" 24 hours a day, 7 days a week, and therefore provide an immediate investigative element to all needed incidents within the City of Orem. Responsible for the intelligence process, this Division maintains close relationships with neighboring jurisdictions and their Investigation Units' counterparts as crime, and the criminal elements, do not respect boarders.



Lieutenant Scott Spieth is responsible for the management of the Investigations Division, overseeing the daily activities of personnel assigned.



Lieutenant Jeff Bailey is the Director of the Utah County Major Crimes Task Force, where five of the Police Department's detectives are assigned.

During the 2021/2022 year the Investigations Division investigated 2575 criminal cases with a closure rate of 52% (this reflects completion of cases closed within the same year they are received).

## **Investigations Division**

#### **General Investigations**

Comprised of six detectives, these personnel handle all investigations referred and assigned to the division, ranging from frauds to homicides. Each detective is skilled in multiple specialties and deploy the latest in investigative technology to professionally and expeditiously solve cases.

#### **Special Victims Unit**

SVU is comprised of one Sergeant and five Detectives tasked with the investigation of sex crimes, child abuse, adult abuse and other crimes against persons (other than sex crimes). There is one Detective assigned full-time to the FBI Cyber Crimes Task Force.

#### Mental Health Unit

Our police departments' MHU is comprised of one full-time detective and one civilian Mental Health Advocate. Together, they are responsible for the follow-up of, and often first response to, all mental health related incidents. Additional duties include activities with the police departments' Peer Support and Wellness.

In 2021/2022 the Mental Health Unit tracked, or made contact with 563 persons involved in, 892 incidents which contained a mental health component. Of those persons followed-up with by the Mental Health Unit, or assisted by our Patrol Division, 41% where admitted to a treatment facility. The unit continues to follow-up with individuals and reassesses what their needs may be in the future.

#### **Victim Advocates**

The Victim Advocates Unit works to provide for the distinctive needs of victims of crime within the City of Orem. The unit is staffed by one civilian supervisor and two civilian advocates, providing crisis intervention, emotional and judicial support, and other critical services.

For the 2021/2022 year, 739 victims have been provided with resources or assistance through the hard work of our Victim Advocates. Of these situations 479 were domestic violence calls for service.

#### **Neighborhood Improvement Team Liaison Officer**

The Department has one detective assigned as the liaison officer working daily with the Neighborhood Improvement Team. The NIT promotes safe and welcoming neighborhoods by increasing awareness of neighborhood codes and properties not in compliance. The team works with many offices of the city to include Police, Mental Health, Community Services and Planning and Zoning.



# **Investigations Division**

#### **Utah County Major Crimes Task Force**

The Utah County Major Crimes Task Force is a group of Detectives from multiple local and federal police agencies in Utah County, assigned to address the problems of drug distribution, gang enforcement, and any major crime as needed by a Chief of Police in Utah County. Over the years Detectives from the Task Force have assisted in most of the high profile homicide and attempted homicide investigations in Utah County. Our Police Department assigns one Lieutenant, the Task Force Director, two Sergeants and two Detectives (SET) to the UCMCTF.





#### **Special Enforcement Team (SET)**

The SET work to identify those involved in continual criminal activity with an emphasis on the use and distribution of illegal narcotics. With its goal of mitigating crime within the City of Orem, the SET work closely with our local partner jurisdictions at the local, state, and federal levels. Two Detectives comprise our SET, and they are assigned to the Utah County Major Crimes Task Force command.

#### **Community Services Unit**

The Community Services Unit is lead by a Sergeant of Police assigned to the Investigations Division, and includes the services of detectives in the unit to accomplish Community Oriented Policing activities. These include events such as National Night Out, high visibility in local schools, Orem's School Reading Program, Autism Awareness, Fraud prevention meetings with senior citizen groups and Crime Prevention with local businesses.



#### **Crime Analysis**

One civilian staff member is assigned to this position. This member assists all areas of the police department in various duties ranging from gathering department statistics, identification of crime hotspots, traffic accident patterns, investigating support, monthly/yearly reporting, and more.

# Support Services Division



Captain Mark Sorensen commands the Support Services Division of the Police Department. Beginning his police career with the Nephi Police Department, Capt. Sorensen lateralled to the Orem Department of Public Safety in 2002 and has served in a number of positions within the Police Department including: Patrol, Investigations Division, Special Victims Unit, and the Utah County Major Crimes Task Force. The Support Services Division is comprised of the Records Department, the 911 Emergency Communications Center, Volunteers In Police Services (VIPS), Evidence, Training, School Crossing Guards and Animal Control.

The mission of the Support Services Division is to: (1) Assist the public in its efforts to provide for its welfare and safety and (2) Provide the training, support and information necessary for the other divisions of the department to perform their duties. This divisions' customer isn't only the public, but the police department as well.



**Lieutenant Nick Thomas** is a Support Services Commander assisting in the daily functions of the division. Lt. Thomas oversees public relations as the Public Information Officer (PIO), Background Investigations, Internal Affairs and Training for the department.



**Lieutenant Michael Paraskeva** is a Support Services Commander. Lt. Paraskeva's responsibilities include supervision of Animal Control, Records, Evidence, Parking, School Crossing Guards, Volunteers in Police Services (VIPS), and 911 Communications.

# **Support Services Division**

#### **Communications**

Orem Communications Center is a 24/7/365 Public Safety Answering Point (PSAP) which receives and dispatches 911 and non-emergency calls for the cities of Orem and Lindon, dispatching Police, Fire, and EMS for both cities in addition to Fire and EMS for the City of Vineyard. In 2021/2022 they handled over 138,000 phone calls, of which 99.71% were answered in under 15 seconds. The calls generated over 38,000 incident reports with more than 6,600 fire/medical incidents.

The Communications Center is staffed by 15 full-time dispatchers and 5 Flex /on-call dispatchers certified through Utah Peace Officer Standards and Training (POST), who are CPR certified, and National Emergency Medical Dispatch certified through the International Academies of Emergency Dispatch, as well as Utah State certified through Utah Bureau of EMS.

#### **Evidence**

The property and evidence sections is staffed by two full-time civilian members. Our evidence technicians play vital roles in solving cases, are responsible for the booking and maintenance of evidence related to cases, as well as found property. The technicians employ skills in the collections of DNA, fingerprints, footprint casting, and more. There are more than 25,00 active items within the Evidence Dept.

In 2021/2022, over 11,000 articles were booked into the evidence department with approximately 5400 photographs of crime scenes, with response to 49 crime scenes.





#### Records

As the first point-of-contact with citizens visiting the Orem Police Department, the department has a wide variety of duties to include the dissemination of records. Staff must maintain compliance with privacy and preservation laws for the records compiled by the police department. Additionally, they manage: entries and additions on citations, accidents forms, GRAMA requests, arrest, Subpoena Duces Tecums, audio/video requests, Uniform Crime Reporting, expungement of records, supplemental document scanning, Notary Public, search warrant transparency reports, address GeoBase updates, medication disposal, public complaints, and more.

The Records office fulfilled 5815 records requests during 2021/2022

#### **Training**

A Sergeant of Police is assigned as the Training Coordinator for the Police Department. This responsibility includes all in-service training for the sworn members of the police department, new hire Field Training of police officers, as well as the tracking and reporting of training to the Utah State Peace Officer Standards and Training (POST). This position is vital to the departments' goal of maintaining highly trained professional law enforcement to the community in which we serve.

### Support Services Division



#### **Parking Enforcement**

During 2021/2022 a Parking Enforcement Team was established within the Orem Police Department to specifically address parking code violation and abandoned auto issues. This unit is comprised of two civilian members who work to educate and gain compliance with city and state parking codes.

#### **Animal Control**

Orem Animal Control is staffed by two full-time Animal Control Officers, under the direction of the Orem Police Department. Normal business hours for the Animal Control are 7:00 AM – 5:00 PM. Monday through Saturday. Our ACO are responsible for enforcing the Animal Control Ordinances of the City of Orem. Animal Control Officers responded to 2433 calls for service during 2021/2022 including 24 animal bites.



#### **Volunteers In Police Services (VIPS)**

The Volunteers in Police Service (VIPS) is a group of citizens dedicated to extraordinary community service through public education. Originally created in 1999, the program has grown to 20 individuals serving their community. The VIPS are trained through the police department, and perform non-hazardous police services to the citizens of Orem. VIPS work as available and as well as assigned shifts to supplement the departments' resources. Some of their duties include: assisting stranded motorists, unlocking car doors, directing traffic, neighborhood patrols, assisting with lost children, crossing guard duty, specific sign ordinances, vacation checks, animal control issues, and many others.

The VIPS volunteered over 2,230 hours in service to our city in the year 2021/2022.

### **School Crossing Guards**


School Crossing Guards are overseen by the Orem Police Department for all schools within the City of Orem. At this time there are 20 full-time crossing guards and 13 Alternatives at 34 crossings in the city. Many of our hardworking guards work multiple school to ensure the safety of our children.



### **Crime Statistics**


The FBI collects and compiles statistics on crime in the United States using the Uniform Crime Reporting (UCR) program. UCR is a nationwide, cooperative statistical effort of nearly 18,000 city, university & college, county, state, tribal and federal law enforcement agencies voluntarily reporting the date on crimes.

Criminal Offenses are divided into two major groups: Part 1 & Part 2 offenses. Part 1 offenses, also known as *Index Crimes*, are 8 offenses that are considered serious crime which occur with regularity in all areas of the country. Part 2 offenses are all other offenses and are tracked on *arrest data only*, rather than occurrence. **Statistics reflect fiscal year 2021/2022 and are rounded to the nearest whole number.** 





### Description of Awards - In order of distinction

<u>Police Medal</u>: Awarded to any Department employee who, in the line of duty, distinguished themselves by performing courageous acts involving personal hazard, or similar acts necessary to affect an arrest to prevent the escape of a person who committed and act which seriously exposed any person to death or serious personal injury. Furthermore, the Police Medal may be awarded to performing highly creditable and unusual police accomplishments.













<u>Life Saving Medal:</u> Awarded to any Department or community member who saved the life of another person.



<u>Distinguished Service Medal:</u> Awarded to a Department member for exceptional accomplishments, which went above and beyond their assigned work duties or responsibilities, and furthered the goals of the department and/or enhanced the livability of the community.



<u>Jim Reams Distinguished Service Medal:</u> Awarded to any Department member who consistently delivers police service in a manner that embodies the values of the City of Orem Police Department. The Department members are to be recognized for their compassion towards others, their excellence in service, and/or shows acts of selflessness, personal courage, and devotion to the community.










<u>Civilian Employee of the Year:</u> Awarded to a non-sworn employee in recognition and appreciation

<u>Dispatcher of the Year:</u> Awarded to an emergency dispatcher who exemplifies excellence in their work throughout the year.




<u>Incident of the Year:</u> Awarded to a group or individual emergency dispatcher who showed exemplary work during a large and high priority incident.
