

**LEGAL NOTICE  
PUBLIC HEARING**

Public hearings will be held at the Orem City Council Chambers on April 11, 2023, at 6:00 p.m. and May 23, 2023, at 6:00 p.m. to consider comments regarding the Statement of Community Development Objectives and Projected Use of Funds for the Community Development Block Grant (CDBG) for FY 2023-2024.

The CDBG program is designed to assist communities in efforts to improve living conditions primarily for low- and moderate-income (LMI) residents by creating suitable living environments, decent housing opportunities, and economic opportunities. To achieve these goals, each project and program must meet at least one of these national objectives established by the United States Department of Housing and Urban Development (HUD). Activities must either benefit LMI persons in a given census tract or block group, including assistance through economic development, improve designated areas of slum and blight, or address an urgent community need.

The City of Orem has approved the following programs and projects which address the primary objective of benefit to LMI persons:

- Housing (affordable, accessible, assistance, and improvements)
- Public Services to Low and Moderate Income Residents
- Public Infrastructure (streets, water, sewer, facilities, parks, and improvements)
- Develop Economic Infrastructure
- Efficient Oversight and Operations of the CDBG Program
- Neighborhood Preservation
- Urgent Need

In accordance with the above stated objectives, each proposal will meet one of the stated national objectives and will be an eligible activity as defined in Section 101(c) of the Housing and Community Development Act (HCDA). The City of Orem intends to meet the requirement of 70 percent benefit to LMI persons in the CDBG program years through 2023-2024. Projects and programs outlined for 2023-2024 each meet the national objective to benefit at least 51 percent LMI persons.

The 2023-2024 CDBG entitlement will be receiving approximately \$632,646.00. Unspent funding from previous years may also be available for reallocation during FY 2023-2024, and is estimated at \$77,601.355. The total amount for allocation in FY 2023-2024 is estimated to be approximately \$710,247.35 although this amount is subject to change based on HUD allocation amount and unspent funding from previous years.

The thirty day public comment period will begin on Friday, March 10, 2023, and will conclude on Monday, April 10, 2023, at 5:30 pm. The CDBG proposals are available for public inspection.
